

## Win a Vespa Terms and Conditions

1. Promotion commences at 12.00 am (AEST) 17 November 2008 and ends at 3pm (AEST) on 15 November 2009 ('Promotion Period').
2. Entry is open to new and existing Sam Miranda Wine club members who must be over the age of 18 years, Employees (and their immediate families) of the Promoter, or agencies or companies associated with this Promotion, are ineligible to enter.
3. To be eligible to participate in the promotion, eligible entrants must be members of the Sam Miranda Wine Club, and purchase at least 6 x 750 ml bottles of Sam Miranda wines per quarter as outlined in the Wine Club membership guidelines for a minimum of 12 months from the date of the prize draw.
4. All new & existing members of the Sam Miranda Wine Club will automatically go in to the draw.
